- The dissertation is a macro-sociological case study of the building up of a modern system of education just before and during Uganda's colonial period. Special attention is being given to the interplay of dominant social and educational trends of the era. Among these are: (1) the increasing structural differentiation both between political and educational organisation and within education itself; (2) the diffusion of a cash crop economy and educational facilities; (3) the emergence of denominational pluralism and the secularisation of the education curriculum; (4) the centralisation and bureaucratisation of control of education; (5) the democratisation of social selection into and within the schools; (6) the increasing adaptation of educational output with opportunities in newly developing occupations. These and other trends are not seen as rigidly correlated or as necessarily unidirectional. Rather there is a possibility for separate forward and back movement along each of these dimensions of change which it is my purpose to trace, explain and, if justified, relate together. The activation and continuation of these trends, none of which is automatic or inevitable, is being sought in the on-going conflict, competition, co-operation and co-optation between significant groups and individuals.

- To find out the personal hopes and fears of the high school students, a coding system has been developed. The coding system is given in the study. Each student was asked to define, on the basis of his assumptions, perceptions, goals, and values the two extremes on which some scale measurement is desired; for example, he may be asked to define the "good" and "bad". This self-defined continuum was used as a measuring device. He describes, at the top, his hopes and at the bottom, his fears as he personally conceives them. Later, utilizing a nonverbal ladder device, he was asked where he thinks he stands on the ladder today, with the top being the best life as he has defined it, the bottom the worst life as he has defined it. He was also asked where he thinks he stood in the past and where he thinks he will stand in the future.

Verbatim reports were taken in the personal interviews with the students. Later, the reports were analyzed and coded according to the coding scheme.
